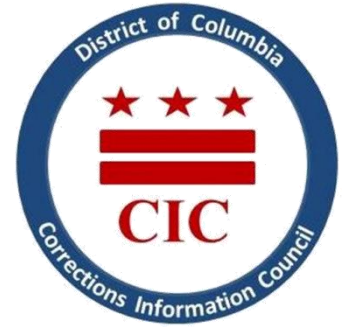


# ARE YOU A CURRENT OR RECENT RESIDENT OF HOPE VILLAGE?
