Federal Bureau of Prisons Regional Support Coordinators

The Federal Bureau of Prisons has established Regional Support Coordinators to foster higher levels of communication and transparency to local, state, and federal external stakeholders. The Regional Support Coordinators are tasked with addressing concerns raised by family members and advocates regarding the provision of adequate resources to adults in custody. While advising and highlighting agency needs for improvement and desired outcomes, the Regional Support Coordinators address both individual and systemic concerns.
