Institution Definitions

FCI – Low security Federal Correctional Institutions (FCIs) have double-fenced perimeters, mostly dormitory or cubicle housing, and strong work and program components. Medium security FCIs (and USPs designated to house medium security inmates) have strengthened perimeters (often double fences with electronic detection systems), mostly cell-type housing, a wide variety of work and treatment programs.

Other – Institutions of varying security levels including camps, metropolitan detention centers, metropolitan correctional centers, residential reentry centers, and any other facilities operated by the federal Bureau of Prisons not otherwise on this list.

USP – High security institutions, known as United States Penitentiaries (USPs), have highly secured perimeters (featuring walls or reinforced fences), multiple- and single-occupant cell housing, high staff-to-inmate ratio, and close control of inmate movement. These institutions can house medium or high security level incarcerated persons.
