She holds BA and JD degrees from Yale University and a MA in human development and social policy from Northwestern University.




Michelle M. Garcia

Representing the District of Columbia

Congresswoman Eleanor Holmes Norton, now in her fourteenth term as the Congresswoman for the District of Columbia, is the Ranking Member of the House Subcommittee on Highways and Transit. She serves on two committees: the Committee on Oversight and Government Reform and the Committee on Transportation and Infrastructure.

Before her congressional service, President Jimmy Carter appointed her to serve as the first woman to chair the U.S. Equal Employment Opportunity Commission. She came to Congress as a national figure who had been a civil rights and feminist leader, tenured professor of law, and board member at three Fortune 500 companies. The Congresswoman's work for full congressional voting representation and for full democracy for the people of the District of Columbia continues her lifelong struggle for universal human and civil rights.

After receiving her bachelor's degree from Antioch College in Ohio, she simultaneously earned her law degree and a master's degree in American Studies from Yale University.



Marc M. Howard Professor of Government and Law and Director of the Prisons and **Justice Initiative Georgetown University**

Marc Morjé Howard is Professor of Government and Law at Georgetown University. He is the founding Director of the Prisons and Justice Initiative (PJI), which brings together scholars, practitioners, and students to combat the problem of mass incarceration. PJI recently launched the Georgetown Prison Scholars Program at the DC Jail, which offers Georgetown the staff, establishing strong community courses (both credit-bearing and non-credit) to incarcerated men and women. Howard also co-directs the Georgetown Pivot Program, to support a cohort of 15-20 returning citizens (formerly incarcerated people) who will spend a year studying entrepreneurship, business, and the liberal arts while also working parttime at Georgetown.

Howard received his B.A. in Ethics, Politics, and Economics from Yale University, his M.A. and Ph.D. in Political Science from the University of California, Berkeley, and his J.D. from Georgetown University.



Sheriff Antionette V. Irving Sheriff's Office City of Richmond

On January 1, 2018, Dr. Antionette V. Irving became Sheriff of the City of Richmond facilitating one of the largest Sheriff's Offices in the Commonwealth, to include over 450 sworn and civilian staff members.

Cigarette Parks Project Manager Pizzuti



Cigarette's project list includes serving as Project Manager for the Franklin County Board of Elections facility and Project Controls Manager for the Franklin County Public Safety Center.


A retired Commander with 21 years of U.S. Navy service, Cigarette is a Registered Contractor in the City of Columbus.


The Honorable Emmet G. Sullivan United States District Court for the District of Columbia

On October 3, 1984, Judge Sullivan was appointed by President Ronald Reagan to serve as an Associate Judge of the Superior Court of the District of Columbia. On November 25, 1991, Judge Sullivan was appointed by President George H. W. Bush to serve as an Associate Judge of the District of Columbia Court of Appeals.

On June 16, 1994, Judge Sullivan was appointed by President William J. Clinton to serve as United States District Judge for the District of Columbia. Upon his appointment as a United States District Judge, Judge Sullivan became the first person in the District of Columbia to have been appointed by three United States Presidents to three judicial positions.

Judge Emmet G. Sullivan was born in Washington, D.C., and attended public schools in the District of Columbia until his graduation from McKinley High School in 1964. In 1968, he received a Bachelor of Arts Degree in Political Science from Howard University and, in 1971, a Juris Doctor Degree from the Howard University School of Law.





Nkechi Taifa is the advocacy director for criminal justice at the Open Society Foundations. Her areas of expertise include federal sentencing reform, executive clemency, law enforcement accountability, and re-entry. Taifa also convenes the Justice Roundtable, a Washington-based advocacy coalition that advances criminal justice reforms.
