Message from the Executive Director



It's officially Spring in the District, and the CIC is working on some exciting things. The team is hard at work finalizing DOC and BOP reports and planning ways to continue to engage with the community in 2022.

Earlier this month, the CIC visited Central Cell Block, finishing our first round of visits to DC's DOC facilities. At the Correctional Treatment Facility, Correctional Detention Facility, and Central Cell Block, the CIC team and our accompanying subject matter experts from the Office of Human Rights were able to discuss conditions of confinement with residents and staff. During the visits, the CIC was able to investigate the concerns expressed by residents as well as members of the advocacy community. The team is currently finalizing information, and reports on each facility are forthcoming.

Lastly, we are proud to announce that the FCI Cumberland inspection report has officially been added to the CIC website. FCI Cumberland is a medium security federal prison facility for adult males located in Cumberland, Maryland. FCI Cumberland is approximately 139 miles from Washington, DC.  - **Increase since February 2022 (2,614 adults in custody)*



A DEEPER LOOK AT SECOND CHANCES

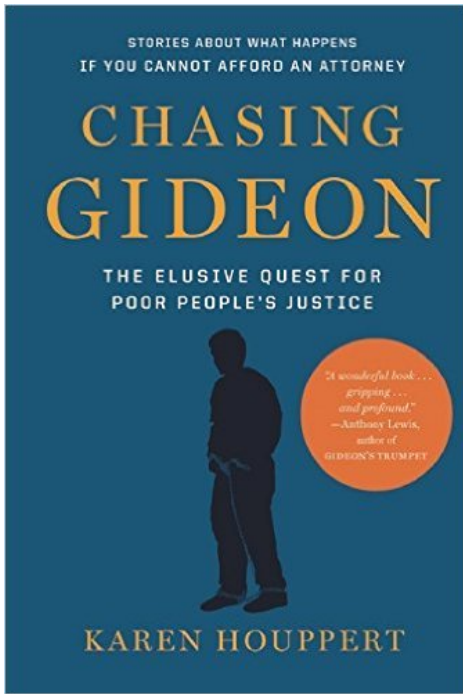
A conversation with three returning citizens on coming home from incarceration, facing negative perceptions, and overcoming obstacles along the way.
