

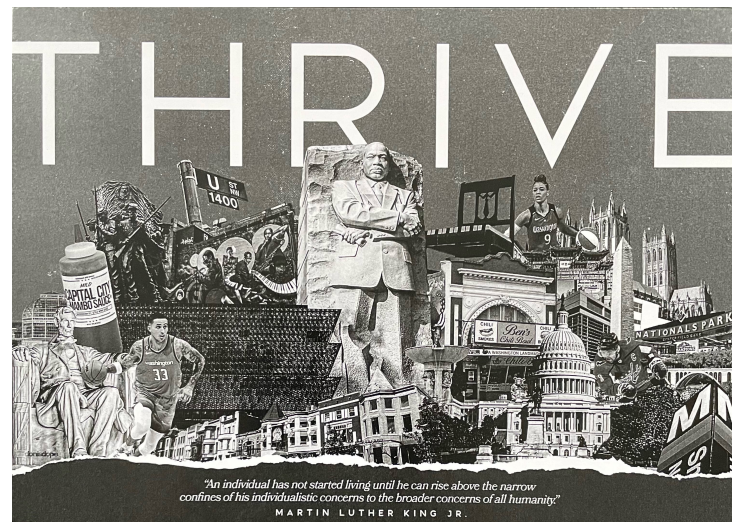


## Message from the Executive Director

With their expertise in Law and Criminology, they will serve as valuable contributors to the CIC's operations and goals for FY23. The CIC is now at full staff capacity, and the agency anticipates a productive year inspecting and monitoring conditions within the local and federal systems.

Last month, the CIC held a postcard signing event to send holiday messages to incarcerated members of the community. We sent over 2,000 holiday postcards to DC residents in custody. The CIC looks forward to continuing this event annually.

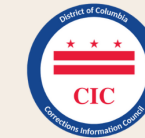
# RESIDENTS IN CUSTODY

## DOC Updates as of December 30, 2022

Under DYRS, there are 17 residents at the Youth Shelter Home, 48 at Youth Services Center, and 47 at New Beginnings totaling to 112.

*• This is the least amount since August 31, 2022 (population of 100).*

There are 909 DC Code Offenders at CDF, 339 at CTF, 33 at CCB, and 1 at Fairview.

There are 631 residents that are pretrial and 21 are on Writ/Hold.

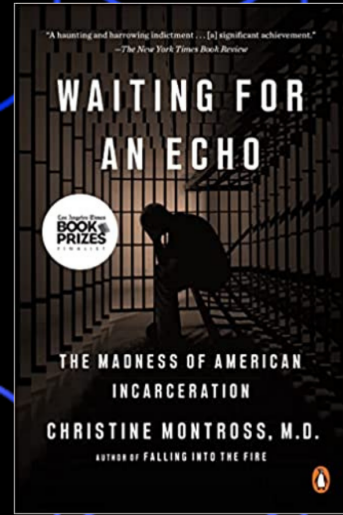

## Waiting For An Echo by Christine Montross, M.D.

*Waiting for an Echo* is a glimpse into mental health in American jails and prisons. Montross uses stories of the battles that those who struggle with mental health face interacting with the justice system. She also evaluates American policies that have criminalized mental illness, shifting large numbers of people who belong in therapeutic settings into punitive ones.

Montross argues that our methods of incarceration take away not only freedom but also selfhood and soundness of mind.
